Policy resolutions approved by the GWI General Assembly (GA) add a critical dimension to the purpose, international advocacy and mission of GWI. They are at the core of GWI and give direction to NFAs and the GWI leadership. They also provide focal points for NFA and GWI Headquarters advocacy strategies with their respective governments and provide the framework for the representatives at the United Nations campuses.

We thank those NFAs who submitted policy resolutions. We have received eight submissions on a variety of issues covering global perspectives.

We urge the NFAs to examine the policy resolutions and provide suggestions for amended text no later than 04 August 2025 to policyresolutions2025@gwi.graduatewomen.org. The amendment must come from the NFA, not an individual. Understandably, late amendments cannot be accepted.

Any suggested amendments will be shared with the proposing NFA. The Official Voting Delegate from any NFA will have an opportunity to discuss the proposed amendment to the policy resolution with the proposing NFA and the Resolutions Committee.

This discussion will be held at virtual meetings (time zone appropriate) ahead of the GA at 0700hrs and 1700hrs CEST on 19 August 2025.
